5. Eligibility Criteria: You are required to meet the following criteria to be eligible:

- a). Supplier shall be registered with relevant registration authority, FBR and shall be an active tax payer;
- b). The supplier shall be an authorized partner/dealer/distributor/reseller for Laptops and IT Server;
- c). Have completed atleast 3 projects of similar nature ;
- d). Have maintenance facility/office in Peshawar for after sales services;
- e). Have the legal capacity to enter into a contract;
